

Omega Appliances Dishwasher Promotional 1 Year Additional Warranty

Terms and Conditions

1. The Omega Dishwashers promotional 1 year additional warranty is a bonus on top of the standard 2 year warranty. The additional warranty provides the same cover against defect and faulty workmanship as the standard warranty policy. Please refer to the original warranty conditions available at www.omegaappliances.com.au
2. Information on how to claim the promotional 1 year additional warranty forms part of these Terms and Conditions. By submitting a claim purchasers are deemed to have accepted these Terms and Conditions. The promotional warranty is not valid in conjunction with any other offer.
3. Purchasers of the following Omega Dishwasher models, between 14th October and 31st December 2011, from participating stores are eligible to claim the promotional 1 year additional warranty. Eligible models codes: ODW507TXB, ODW507TWB, ODW702XB, ODW702WB, ODW704XB, ODW704WB, ODW707XB, ODW707WB.
4. To claim the promotional warranty, purchasers must complete an online registration at www.omegaappliances.com.au within 6 months of the purchase date.
5. The original purchase receipt marked paid in full and approved promotional warranty certificate must be retained for a 3 year period. Failure to produce these may, at the Promoter's discretion, invalidate a claim under the promotional warranty.
6. Service under the warranty must be provided by an authorised Omega Appliances repairer.
7. The Promoter reserves the right, at any time, to verify the validity of claims (including contacting the place of purchase) and claimants (including a claimant's identity and place of residence) and to disqualify any claimant who submits a claim that is not in accordance with these Terms and Conditions or who tampers with the claim process. Failure by the Promoter to enforce any of its rights at any stage does not constitute a waiver of those rights.
8. Except for any liability that cannot be excluded by law, the Promoter and participating outlet (including their officers, employees and agents) excludes all liability (including negligence), for any personal injury; or any loss or damage (including loss of opportunity); whether direct, indirect, special or consequential, arising in any way out of the promotion, including, but not limited to, where arising out of the following: (a) any theft, unauthorized access or third party interference; (b) any claim that is late, lost, altered, damaged or misdirected (whether or not after their receipt by the Promoter or the participating outlet), 9c) any technical difficulties or equipment malfunction (whether or not under the Promoter's control). Incomplete, indecipherable or illegal claims will be deemed invalid.
9. The Promoter's decision is final and no correspondence will be entered into.
10. The promotional warranty is not exchangeable or redeemable for cash, or any other consideration, or transferable to any other Omega product.
11. The claimant is responsible for any cost accessing the promotional website.
12. The Promoter collects personal information in order to conduct the promotion and may, for this purpose, disclose such information to third parties, including, but not limited to, its suppliers and as required, to Australian regulatory authorities. Claims are conditional on providing this information. If the claimant does not mark the applicable box, the Promoter may, for an indefinite period unless otherwise advised, use the information for promotional marketing and publicity purposes including sending electronic messages or telephoning the claimant. Claimants should direct any requests to access, update or correct information to the Promoter. All claims become the property of the Promoter.
13. Claims will be invalid if:
 - (a) A qualifying product purchase is not registered correctly at www.omegaappliances.com.au within 6 months after the purchase date.
 - (b) Proof of purchase details fail to match the registration details.
 - (c) Qualifying purchase has not been paid in full by the end of the Promotional Period.
